

Lucky Draw Promotion "2021 Lao New Year Promotion"

TERMS & CONDITIONS

- 1. The promotion period for "2021 Lao New Year Promotion" (the "**Promotion**") is from 1st April 2021 to 30th June 2021 (the "**Promotion Period**").
- 2. The Promotion and the Lucky Draw will be administered and run by J&C Insurance Brokers Co.,Ltd.

3. As part of the Promotion:

All clients of J&C Insurance Brokers Co.,Ltd. who successfully purchase any insurance product from Phongsavanh Insurance (APA) Co., Ltd. Through us during the Promotion Period will be eligible to participate ("**Eligible Participant**") in a lucky draw that will be conducted on 15th July 2021, where winners will be randomly selected for the following prizes:
